

## **HKUST Dream Builder 2025-2026 Cohort#2**

### **Application Guideline, Terms, and Conditions**

#### **1. Target Participants:**

- Start-up projects / companies initiated by HKUST students, alumni or staff that are at early stage working on their proof of concept and/or development of minimum viable product (MVP) / prototype

#### **2. Objectives and Deliverables:**

- To facilitate start-up projects in completing their proof of concept and developing their MVP/ prototype through seed funds, training and in-kind support in the Program
- By the end of Program, start-up teams are expected to:
  - Define and/or refine business model, customer journey and product design
  - Complete proof of concept
  - Successfully develop an MVP/ prototype
  - Collect / ready to collect market feedback
  - Complete business registration
  - Be equipped with the necessary knowledge and skillsets for further development of their start-ups

#### **3. Eligibility:**

- Team or company applications are both accepted.
- The main applicant must be a full-time current student (undergraduate or postgraduate) of HKUST till the end of project within the supporting period, while other team members can be HKUST students, alumni or staff.
- If the start-up is already a registered company, the company shall have been registered for no more than one year at the time of application.
- At least two HKUST full time current students are playing important roles (Founder/ Co-founder) in the project.
- Start-up projects in the following clusters are welcome to apply:
  - Advanced Manufacturing & Logistic
  - Advanced Materials
  - AI & Big Data
  - Biotechnology & Healthcare
  - Design, Multimedia & Infotainment
  - Education
  - Electronics
  - Energy & Environmental Technology
  - Information & Communication Technology
  - Social Enterprise

#### **4. Selection Criteria:**

- Team competency (25%): individual qualifications and strengths, track record, execution ability and commitment, roles of members, advisory support
- Business potential (25%): market research, landscape and feasibility, value proposition, competitive advantage, development plan and milestones
- Innovation & disruption to industry (25%): potential to disruptive the industry/ market, technology involved (if any), solution uniqueness
- Social value and impact (25%): contribution to society

## 7. Application Process

- Interested applicants are required to apply online; only one start-up project/team is allowed per application.
- One person may submit multiple applications but only one particular start-up project will be admitted.
- Shortlisted start-up projects will be invited to a screening interview with panel composed of representatives from HKUST.

## 8. General Terms and Conditions

8.1 Any significant changes or deviations from the original approved application, including but not limited to the start-up nature, team composition, budget, proposed business, etc., must be reported to the HKUST EC for assessment and approval in advance of the change.

8.2 HKUST reserves the right to suspend and terminate the participation of the admitted start-up in the Program, the associated funding support/ award, request the start-up to recover any funds/ awards disbursed and/or pursue any legal actions in any of the following events:

- the actual start-up/project/plan carried out that deviates from the approved execution plan;
- the seed fund provided in this Program has been mishandled or utilized for purposes that deviate from the objectives, terms and conditions of the fund/ award;
- the admitted start-up fails to complete the Program requirements and/or submit falsified reports;
- the admitted start-up is involved in illegal or unethical business practices; or
- lacking of progress of the start-up project in a material way and/or low chance of completion of the approved execution plan.
